A BILL

To terminate the application of title IV of the Trade Act of 1974 with respect to the People's Republic of China.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. TERMINATION OF APPLICATION OF TITLE IV**
2 **OF THE TRADE ACT OF 1974 TO THE PEOPLE'S**
3 **REPUBLIC OF CHINA (CHINA).**

4 (a) **PRESIDENTIAL DETERMINATIONS AND EXTEN-**
5 **SION OF NONDISCRIMINATORY TREATMENT.**—Notwith-
6 standing any provision of title IV of the Trade Act of 1974
7 (19 U.S.C. 2431 et seq.), the President may—

8 (1) determine that such title should no longer
9 apply to China; and

10 (2) after making a determination under para-
11 graph (1) with respect to China, proclaim the exten-
12 sion of nondiscriminatory treatment (normal trade
13 relations treatment) to the products of that country.

14 (b) **CHINA'S ACCESSION TO THE WORLD TRADE OR-**
15 **GANIZATION ("WTO").**—Prior to making the determina-
16 tion provided for in subsection (a)(1) and pursuant to the
17 provisions of section 122 of the Uruguay Round Agree-
18 ments Act (19 U.S.C. 3532), the President shall transmit
19 a report to Congress certifying that the terms and condi-
20 tions for China's accession to the WTO are at least equiva-
21 lent to those agreed between the United States and China
22 on November 15, 1999.

23 **SEC. 2. EFFECTIVE DATES.**

24 (a) The extension of nondiscriminatory treatment
25 pursuant to section 1(a)(1) shall be effective no earlier
26 than the effective date of China's accession to the WTO.

1 (b) On and after the effective date under subsection
2 (a) of the extension of nondiscriminatory treatment to the
3 products of China, title IV of the Trade Act of 1974 shall
4 cease to apply to that country.
